

SUAVE 5, International Juried Textile Accesories Triennial

Participation Rules

The Asociación de Creadores Textiles de Madrid is organizing SUAVE 5, an international juried exhibition of textile fashion complements: bags, caps, fans, foulards, gloves, hats, headdresses, jewelry, mittens, parasols, scarves, shawls, shoes, ties, turbans, umbrellas,,,,, Excluding costumes and garments, everything that can be worn and bear some relation to textiles because of the techniques and/or materials employed or through the underlying concept, can apply for this fifth edition.

1. Application Conditions

Each candidate may submit a maximum of two works (or a set of 4 pieces of jewellery maximum). A complete dossier, in English or Spanish, must comprise the following:

- The filled and signed registration form.
- Two digital pictures per work minimum, in.jpg or tiff format. The minor possible height of the pictures will be of 450 pixels, with proportional width and 72 ppi of resolution.
- The artist's statement (300 words maximum).
- Receipt of payment of a 40 euros inscription fee for all abroad applications (20€ for Spanish residents except for ACTM and OAE members).

Applications coming from Spain must pay the inscription fee by bank (Bankia 2038 1179 4660 0024 0878 to the name of Asociación de Creadores Textiles de Madrid).

Candidats from abroad, please, consult the organizers about the recommended way of payment. We are looking for the more convenient way for you and us. **Bank transfers from abroad will not be accepted.**

Dossiers should be sent to actm@creadorestextiles.org or to Asociación de Creadores Textiles de Madrid. Apartado de Correos 14.060. E-28028, Madrid, Spain, before April, 1st, 2013. Only complete dossiers will be considered. Dossiers will become property of the organizers.

Please, note that **Apartado de Correos means P.O.Box** and will only accept envelopes and boxes sent by post. If using a private courier is more convenient to you, please, ask the organizers to provide you with an alternative address to avoid undesirable delays and expenses.

By taking part in this competition, the candidate declares his/her agreement with the provisions of these regulations. In case of disagreement only the courts of justice of Madrid will be competent.

2. Selection

All submitted works fulfilling the requirements contemplated in these regulations will be uploaded to a virtual Internet gallery to be selected by a jury of three international experts plus a fourth member composed by ACTM members willing to vote and from whose votes the average will be found for each piece. The decision of the jury is final and binding. Candidats will be informed about the result of selection and the jury members before April 30th 2013 and also about identity of the jury members.

The organization reserves the right to invite such designers and makers as it sees fit to participate in the exhibition.

3. Exhibition

The selected works will be shown at an exhibition space either at the Museo del Traje or at the National Museum of Decorative Arts, both in Madrid, in the frame of Creatextil 2013, a textile meeting organized by the Actm to celebrate its 25th anniversary taking place May 30th to June 2nd.

The exhibition final venue will be announced later on. If the exhibition is in the National Museum of Decorative Arts **exhibition dates will be May 23rd to June 30th 2013**. Dates for the Museo del Traje would be very similar.

The organization can refuse any work that does not correspond to the delivered documentation.

Candidates agree to make the selected work/s available for the entire duration of the exhibition and allow them to be reproduced with the only aim to promote the event.

There not will be a printed catalogue. However all selected works will be part of the permanent virtual exhibition at www.creadorestextiles.org and the authors' names and contact data will be fully visible.

The organizers might take SUAVE 5 to another cities, (before the end of 2014 as maximum). These shows will not necessarily cover the entire contents of the Madrid exhibition. The organizers reserve the right to choose a selection of the works.

Exhibitors who wish the works returned at the end of the Madrid exhibition must say so in the inscription form.

4. Transport and Insurance

Selected works will be sent to Madrid at the expense and risk of the participants. In all cases, returnable packaging should be used. Parcels not responding to these prescriptions will be refused.

At the end of the exhibition, works will be sent back. The organizers will pay only freight costs but will not be responsible for any customs fees and formalities nor any other costs. Actm members must pay for the return costs.

The exhibition venue is covered only by the public liability insurance.

5. Participation Cost.

There will be no additional participation fee. Works will not be on sale. Contacts among authors and interested parties will be facilitated.
